 - Item 1.1 The definition of "revenue" and an explanation of "ordinary activities" are set out in *AASB 1004: Revenue*, and *AASB 1018: Statement of Financial Performance*.
 - Item 1.6 This item refers to the total tax attributable to the amount shown in item 1.5. Tax includes income tax and capital gains tax (if any) but excludes

taxes treated as expenses from ordinary activities (eg, fringe benefits tax).

4. **Income tax** If the amount provided for income tax in this report differs (or would differ but for compensatory items) by more than 15% from the amount of income tax *prima facie* payable on the profit before tax, the entity must explain in a note the major items responsible for the difference and their amounts. The rate of tax applicable to the franking amount per dividend should be inserted in the heading for the column "Franked amount per security at % tax" for items 15.4 to 15.7.

5. **Condensed consolidated statement of financial position**

Format The format of the consolidated statement of financial position should be followed as closely as possible. Additional material lodged with the +ASIC under the Corporations Act must also be given to ASX. For example, a director's report and declaration, if lodged with the +ASIC, must be given to ASX.
12. **Accounting Standards** ASX will accept, for example, the use of International Accounting Standards for foreign entities. If the standards used do not address a topic, the Australian standard on that topic (if one exists) must be complied with.

Entities must either provide a description of any significant activities or events relating to discontinuing operations equivalent to that required by paragraph 7.5 (g) of *AASB 1029: Interim Financial Reporting*, or, the details of discontinuing operations they are required to disclose in their ⁺accounts in accordance with *AASB 1042 Discontinuing Operations*.

Appendix A

DISCUSSION AND ANALYSIS

CONSOLIDATED STATEMENT OF FINANCIAL PERFORMANCE

The year under review was primarily focused on listing the Company on the ASX. The Company was admitted to the official list of the Australian Stock Exchange on Monday, 14 July 2003 and listed on the exchange on Thursday, 17 July 2003.

During the year preparations for initial development at Hill End were undertaken and exploration over EL 5868 continued. Subsequent to listing the construction of the access road to the Reward Gold Project has commenced and the sourcing of equipment and appointment of key personnel has started. Exploration on EL 5868 has identified a potential relationship between high grade gold zones in the Hill End Anticline and cross-cutting structures of similar alignment to the Lachlan Transverse Zone. Interpretation of local controls to the gold mineralisation, following surface mapping and sampling, has indicated a correlation between gold occurrences and a critical proximity to fold axes.

CONSOLIDATED STATEMENT OF FINANCIAL POSITION

In October 2002, the Company raised \$539,411 in seed capital to extinguish existing debts, undertake exploration and fund the listing of the Company on the Australian Stock Exchange Limited ('ASX').

CONSOLIDATED STATEMENT OF CASH FLOWS

Cashflows from operating activities increased reflecting the higher level of cash on deposit from the fund raising in October 2002.

Cashflows from investing activities comprise funds spent on exploration activities.

Cashflows from financing activities reflect the share issue in October 2002 to extinguish existing debts undertake exploration and fund the listing of the Company on the Australian Stock Exchange Limited ('ASX').
